**Sales promotional lotteries**

6 months 2015 there were issued by the Inspection:

- 133 lottery permissions (for lotteries prize fund whereof is larger than 720 EUR;
- 318 lottery confirmations (for lotteries prize fund whereof is smaller than 720 EUR).

Total prize fund being subject to a state fee shall be **846 039 EUR** and the state fee collected constitutes **206 271 EUR**.
